Course Description:

Power Sports introduces students to a variety of small engines and the diagnostic process of maintaining equipment. Students will be responsible to diagnose/troubleshoot small engine equipment such as, lawn mowers, generators and weed eaters.. They are expected to locate parts

through internet or parts catalogs, complete a work order, and communicate the diagnostic findings and project cost to the customer

Course Content/Objectives:

Upon completion of this course, students will be able to:

1. read and comprehend small engine book
2. identify and utilize shop tools to perform necessary engine repairs
3. troubleshoot/diagnose problems, rebuild small engines, look up parts for an estimate and complete customer repair orders
4. Junior year students can receive certificate for fork lift training, Win-Learn certificate at level 5 or better.

Do to Covid -19 , Students will also be doing virtual on line classes through Schoology when they are not in person with their Instructor. On the off days students will have assignments sent to them through Power Sport Instructor through Schoology.

Juniors are graded 50 percent hands-on/50 percent written assignments and tests.

They are expected to locate parts through internet or parts catalogs, complete a work order, and communicate the diagnostic findings and project cost to the customer

Course Content/Objectives:

Upon completion of this course, students will be able to:

1. Read and comprehend shop manuals
2. Identify and utilize shop tools to perform necessary engine repairs
3. Troubleshoot/diagnose problems, rebuild UTV, ATV and Motorcycle engines, look up parts for an estimate and complete customer repair orders
4. Senior year students can receive certificate for OSHA 10 safety course and NOCTI state certification exam for small engine repair at 80 percent passing

Do to Covid-19, Students will also be doing virtual on- line classes though Schoology when they are not in person with their Instructor. On the off days students will have assignments sent to them ffrough Power Sport Instructor through Schoology.
